The Chairman of the committee welcomed the representatives of the firms and commenced the meeting.

Representatives of the companies/firms have sought for certain clarification on the tender document. The company clarified these points one by one. Various queries (**Q**) raised by the representatives and the responses (**R**) provided by the Tender committee are documented as under:

**Q-1:** Clause No.:9: Price bid:

As there is ambiguity in the percentage of GST applicable on this product, can the price be quoted exclusive of taxes?

**R:** The Tender clause is unchanged. The bidder has to quote all-inclusive price for supply, handling, transportation, Testing, Commissioning of Ticker display systems with breakup of tax/duties/levies components in the e-procurement portal of Government of Karnataka.

**Q-2:** Clause No.30: Payment Terms:

Can payment be released against partial supplies and on completion of work.

**R:** Payment will be released only after completion of supply, installation and commissioning of all the 20 units.

**Q-3:** Clause No.27.1: Delivery period:

The tender clause prescribed 8 weeks for completion of the work in all respects.

Since goods are to be imported and is to be custom made the delivery period to be changed to 15 weeks?

**R:** The delivery period of the clause is modified from 8 weeks to 12 weeks.

**Q-4:** Clause No.31.1: Technical Specification: In Annexure-IV:

What data will be displayed on LED videowall?

**R:** LED videowall has to replicate the data shown in the PC screen.

**Q-5:** Clause No.31.1: Technical Specification: In Annexure-IV:

Need clarification on Pixel density and pixel pitch.

**R:** Pixel pitch is 4.0 mm or less with better pixel density.

**Q-6:** Can POC date be extended? since it is difficult to arrange the videowall for the defined specification.

**R:** POC date is extended to 30.10.2019.

As the intending bidders have no other points to be clarified, the Chairman thanked all those present and the meeting was concluded.
